

OFFSHORE MOZAMBIQUE FIELD DEVELOPMENT PROJECT PUBLIC ANNOUNCEMENT FOR EXPRESSION OF INTEREST

Eni East Africa S.p.A., a company incorporated under the laws of Italy with a branch in the Republic of Mozambique (hereinafter referred to as "**Eni East Africa**"), Operator of offshore Area 4 located in the Rovuma Block in the Republic of Mozambique, is evaluating, as part of the development strategy for Area 4, the supply of line pipe, associated pipe bends, anti-corrosion coating and bracelet anodes for cathodic protection.

Eni East Africa invites interested local and international companies, hereinafter referred to as "Candidates", to participate in the **Expression of Interest** for the following potential Tender:

Scope of Work

Supply of 16" SAWL L450 internally metallurgically cladded line pipe, anti-corrosion coating, pipe bends and bracelet anodes for cathodic protection, for Mozambique Offshore Development Projects.

This is not an invitation to participate in the above-mentioned potential Tender but only an invitation to participate to the Expression of Interest. If you wish to participate, please address your letter of interest duly signed by the authorized person (together with notarized powers of attorney or other evidence of authority of such authorized person satisfactory to Eni East Africa) and submit the following mandatory information and documentation by registering on our website indicated below:

Evidence of:

- (i) Proven experience in supply of equivalent size (14 to 18 inches OD with 25 to 30mm WT of UNS N06625 CRA Clad (metallurgically bonded) steel line pipe for subsea gas transportation application;
- (ii) Proven experience in line pipe supply, for a single contract, of more than 35 km for the aforementioned 14 to 18 inches line pipes;
- (iii) Proven experience in supply of anti-corrosion coatings for offshore application for the aforementioned size and type of line pipes;
- (iv) Proven experience of bracelet anode supply for subsea pipeline cathodic protection;
- (v) Proven experience in line pipe logistics and delivery across countries and via overseas transportation;
- (vi) Proven experience in supply of cladded pipe bends
- (vii) Optional: proven experience in supply of equivalent size (20 to 28 inches OD with 30 to 45mm WT) of UNS N06625 CRA Clad (metallurgically bonded) steel line pipe for subsea gas transportation application;
