- 4. Compliance declaration;
- 5. Documented proof of 4 years' experience in the Oil&Gas domain for Offshore Activity relevant to the Supply of Marine Gas oil offshore;
- 6. At least three documented professional references justified by customer testimonials (documented).for the supply of Marine Gasoil offshore;
- 7. Scanned copy of the Operating Licence issued by the relevant Mozambican Authorities (Ministry of Energy) as per requirements of Decree no. 45/2012 (the "Downstream Legal Regime");
- 8. Evidence of capability to supply around 2500 Metric tons/month of Marine Gas Oil or MGO which must comply with the provisions of International Standard ISO 8217 Fourth edition 2010 Petroleum products Fuels (class F) Specifications of marine fuels and, in all respects, with the requirements specified in International Standard ISO 8217:2010(E) for marine distillate fuels Category ISO-F-DMA.
- 9. Latest balance sheet/Annual Report of the company and of the company group (if applicable) proving minimum financial capacity for the realization of the scope of work.
