4. Documented proof of at least 5 years' experience in provision of the services for projects of similar nature;
5. Evidence of Health, Safety and Environment Management System that complies with the requirements of International standard (ISO 14001, OHSAS 18001, etc);
6. Evidence of Quality Management System in compliance with ISO 9001:2008;
7. Financial balance sheets (last year)/Annual Report proving minimum financial capacity for the realization of the scope of work.
