

EXPRESSION OF INTEREST

FOR ROTARY WINGS ONSHORE AND OFFSHORE TRANSPORTATION SERVICES IN MOZAMBIQUE

Eni East Africa S.p.A. invites interested companies to submit expressions of interest for the provision of rotary wings onshore and offshore transportation services in the Republic of Mozambique.

SCOPE OF WORK

Company's scope of work will consist of delivering Air Transport Services, including the transportation of Company personnel and internal cargo and perform medical and technical emergency flights.

Additionally the Operator should be able to perform daylight onshore/offshore SAR (Search & Rescue) as secondary task, when so requested by the Company, to/from the Company onshore/offshore sites of interest.

REQUIREMENTS FOR HELICOPTER

Air Operators, which are certified to operate in Mozambique or which, at the deadline for the receipt of the *Expression of Interest* specified below, have already applied to obtain the certification to operate in Mozambique, are invited to express their interest in offering the above described services by mean of rotary wings having the following characteristics:

- Aircraft certification basis: FAR Part 29 / EASA CS 29
- Class 1, Category A certified;
- IFR/ILS Operation CAT I approved;
- Helicopter configuration:
 - > 8 pax (crew excluded) equipped for onshore and offshore medical evacuation; and/or
 - ➤ 12 pax (crew excluded) equipped for onshore and offshore medical evacuation;

Tender technical specifications will detail Company's standards and the requirements for the service.

- 6. Air Operator Certificate valid in Mozambique and related certification specifications;
- 7. Quality Management System Manual in compliance with international Quality Standards (ISO 9001:2008);
- 8. Quality Management System certifications and/or certificates proving the Company compliance with national or international Quality Standards (e.g. ISO 9001:2008);
- 9. Health & Safety Management System certification and/or documents proving the company compliance with international standards(ISO18001);
- 10. Latest balance sheet/Annual Report of the company registered in Mozambique and the latest consolidated balance sheet/Annual Report of the company group (if applicable) proving minimum financial capacity for the realization of the scope of work.
